**PLAINTIFF’S MOTION TO

17 this Honorable Court to continue (reschedule) the Show Cause Hearing which is currently scheduled

19 1. Per the Court’s Orders of May 17, 2013 (ECF No. 51) and May 22, 2013 (ECF No.
20 55), a Show Cause Hearing was set for June 7, 2013 at 10:30 am.

21 2. Plaintiff’s counsel was prepared to appear at the Show Cause Hearing, and was
